

AGREEMENT BETWEEN
THE CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION AND THE STATE OF
CALIFORNIA, CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION
CALIFORNIA CORRECTIONAL INSTITUTION,
REGARDING CONVERSION OF FACILITY B, BUILDINGS ONE THROUGH SIX
(CDCR LOG # 16-071-0/CCPOA NG #44917)

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on September 12, 2016, regarding the Conversion of the Facility B Housing Units 1-6 from Security Housing Unit to a Level IV Sensitive Needs Yard. This agreement becomes an addendum to the current State Bargaining Unit 06 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2018.

- CCI management agrees that a "black top" recall of the yard will begin at 1345 hours and will conclude at the completion of shift change at 1415 hours.
- CCI management agrees that 1345-1415 hours there will be no inmate movement in the Housing Unit Rotundas barring any emergencies.
- CCI management agrees the Facility 'B' gym population will not normally exceed 30 participants in normal gym activities during scheduled yard time. Due to unforeseen circumstances (e.g., inclement weather, tournaments, events, programs, etc.), the population may exceed 30 participants in gym activities.

CCI management agrees to meet locally with the CCPOA chapter, within 60 days of full activation, to discuss and reassess the amount of gym participants.

- CCI management agrees to provide temporary relief coverage of Facility 'B' Observation Gym Officer for purposes of attending to personal care/needs.
- CCI management agrees to make every effort to provide monthly simulated alarm response training to all Facility 'B' BU6 staff on all watches.
- CCI management agrees to evenly distribute Facility "B" inmates, upon full activation, to all six (6) housing units, barring any unforeseen circumstances.
- CCI management agrees that yard release protocol for the SNY population will consist of two (2) designated housing units out at any one time excluding A1A assigned workers on their RDO's. (Mon.- Fri.)
- CCI management agrees to meet locally with the CCPOA chapter within 30 days, once the kitchen is fully operational and after the PIA and Vocational Programs are activated to discuss the possibility for adjustment of start/stop times for all yard and gym officers.

- CCI management agrees that dayroom activities will not normally occur during times when the exercise yard program is being conducted.

In the event there is no exercise yard program and dayroom activities are conducted, one (1) section of dayroom activities per impacted housing unit shall be run at a time, with additional assistance.

- CCI management agrees housing unit Floor Staff from adjoining housing unit scheduled for yard will be responsible to assist with yard release/recall.
- CCI management agrees to make every attempt to cluster all of the orientation/'C' Status population in one (1) of the six (6) housing units.
- CCI management agrees that the Facility 'B' A1A assigned worker population will have one (1) morning yard and one (1) afternoon yard each weekend.
- CCPOA and CCI management agree to meet locally within 60 days of the date of this Agreement, at the request of either party, to discuss unforeseen impact issues.


