



AGREEMENT BETWEEN

(CDCR LOG # 16-108-0)


This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on September 21, 2016, regarding the Consolidation of the Administrative Segregation Units (ASU) at Chuckawalla Valley State Prison (CVSP) and Ironwood State Prison (ISP). This agreement becomes an addendum to the current State Bargaining Unit 06 Memorandum of Understanding, Article 27, Section 27.1, which expires on July 2, 2018.


1. CCPOA and CVSP Management agree that ISP's ASU Population transferred to CVSP's ASU shall be included in CVSP's population consistent with the institution's Correctional Counselor ratios.
2. CCPOA and CVSP Management agree that ISP's transportation team shall take ISP's ASU population to CVSP's Receiving and Release during the 2<sup>nd</sup> and 3<sup>rd</sup> watches (Monday-Friday). During 1<sup>st</sup> watch and 3<sup>rd</sup> watch (weekends and holidays), ISP's transportation team shall transport ISP's ASU population to Central Health.
3. CVSP Management agrees that ISP's ASU population housed in CVSP's ASU that require transportation to either court or outside medical shall normally be transported by CVSP staff.
4. CCPOA and CVSP Management agree to reopen this table at the request of either party within 90 days of the date of this agreement to address any unforeseen impact that may arise.


