


This agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on December 8, 2016, regarding the Very Special Puppy Basic Obedience/Veterans Service Dog Program. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2018.

1. VSP and CCPOA agree to place signs on the doors where the Very Special Puppy Basic Obedience/Veterans Service Dog Program are housed utilizing existing resources.
2. VSP and CCPOA agree that unless there is an emergency, BU06 staff shall not be tasked with additional workload in association with the VSP Very Special Puppy Basic Obedience/Veterans Service Dog Program other than the duties currently established.
3. VSP and CCPOA agree that Housing Unit Officers assigned to the Housing Unit that is designated to house the Very Special Puppy Basic Obedience/Veterans Service Dog Program participants will not be utilized to supervise the participants, while on the yard, during inclement weather/modified program unlocks.
4. CSP and CCPOA management agree that all Very Special Puppy Basic Obedience/Veterans Service Dog Program participants shall wear a designated vest while actively participating with the dogs outside of the housing unit, utilizing existing resources.
5. VSP and CCPOA agree that the Local CCPOA Chapter President or designee shall be notified of any aggressive dog bite causing injury to a BU06 staff by Very Special Puppy Basic Obedience/Veterans Service Dogs.






