PERB will make an initial determination of whether a petitioning provider organization has evidenced a sufficient showing of support designating the provider organization to act as the representative for providers in the above proposed unit. (Cal. Educ. Code § 8434, subds. (c)(1)-(3).) If appropriate, a confidential, mail-ballot election may be conducted by PERB or its designated neutral third-party. (Cal. Educ. Code § 8434, subd. (d)(1).) PLEASE NOTE: TO BE ELIGIBLE TO VOTE, A PROVIDER MUST HAVE RECEIVED A SUBSIDY PAYMENT DURING ANY OF THE FOLLOWING MONTHS: NOVEMBER 2019, DECEMBER 2019, AND JANUARY 2020.

THIS IS AN OFFICIAL NOTICE. CALHR MUST PROVIDE NOTICE OF THE PETITION TO FAMILY CHILDCARE PROVIDERS AS SOON AS POSSIBLE, BUT IN NO EVENT LATER THAN 10 CALENDAR DAYS FOLLOWING RECEIPT OF THIS NOTICE. NOTICE SHALL BE PROVIDED EITHER THROUGH EMAIL, WEBSITES, OR OTHER MEANS CALCULATED TO PROVIDE NOTICE TO PROVIDERS WHO PARTICIPATE IN THE STATE SUBSIDY SYSTEM, AND MUST REMAIN POSTED FOR A MINIMUM OF 20 CALENDAR DAYS. THE NOTICE SHALL NOT BE REDUCED IN SIZE, DEFACED, ALTERED OR COVERED WITH ANY OTHER MATERIAL.
