**Covered employee:**

- A person who operates (i.e., drives) a Commercial Motor Vehicle (CMV) with a gross vehicle weight rating (gvwr) of 26,001 or more pounds;
  - or is designed to transport 16 or more occupants (to include the driver);
- or is of any size and is used in the transport of hazardous materials that require the vehicle to be placarded.
