LOCAL AGREEMENT BETWEEN THE CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION (CCPOA) AND

DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR),
SALINAS VALLEY STATE PRISON (SVSP), AND CALIFORNIA CORRECTIONAL HEALTH
CARE SERVICES (CCHCS) IMPLEMENTATION OF THE CALIFORNIA PRISON INDUSTRY
AUTHORITY (CALPIA) HEALTH FACILITY MAINTENANCE (HFM) PROGRAM PHASE 2
CLEANING ON FACILITY C YARD, BUILDINGS 5, AND 6, AND FIRST WATCH (1W) IN THE
PSYCHIATRIC INPATIENT PROGRAM (PIP)

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on August 25, 2020, regarding the implementation of the SVSP/CGHCS/CALPIA HFM Phase 2 Cleaning on Facility C5 and C6, and I W in the PIP. This Agreement becomes an Addendum to the current State Bargaining Unit 6 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2022.

- I. The State (SVSP) and CCPOA agree that CALPIA Offender workers will not require custody escort to work in C5 and/or C6, during normal program.
- The State (SVSP) and CCPOA agree that BU6 members will not be required to remove the PIP Offender from their cell for CALPIA workers to conduct routine cell cleaning.
- The State (SVSP) and CCPOA agree that CALPIA Offender workers will move to another area when PIP Offenders are being released inside the building, to avoid comingling with PIP Offenders.
- 4. The State (SVSP) and CCPOA agree that CALPIA Offenders assigned to clean C5 and C6 will be required to eat and take their breaks under the direct supervision of the CALPIA supervisor, away from PIP offenders, including inside pod area (provided PIP offenders are not outside their cells). If inclement weather occurs, the CALPIA offenders will be accommodated inside the building without comingling with PIP Offenders,
- The State (SVSP) and CCPOA agree that assigned CALPIA Offender workers will be within the line of sight of their assigned supervisor while cleaning
- The State (SVSP) and CCPOA agree, at the request of either party, to reopen this table within
 ninety (90) days of the date of closure of this table to address any unforeseen or unresolved
 workload impact issues which could not be resolved locally.
- 7. The State (SVSP) and CCPOA agree, that only CALPIA workers from Facility C General Population will be assigned to work at C5 and C6.
- The State (SVSP) and CCPOA agree, that when CALPIA submits a thirty (30) day memo for first
 watch cleaning, they will provide SVSP CCPOA Chapter President or designee with a copy.
