REHABILITATION (CDCR)  
REGARDING THE IMPLEMENTATION OF THE CONSERVATION (FIRE)  
CAMP OPIOID OVERDOSE PROGRAM FOR INMATES  
(CDCR LOG #20-123-0)

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on February 11, 2021, regarding the implementation of the Conservation (Fire) Camp Opioid Overdose Program for Inmates. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2022.


- CDCR agrees the initial rollout of the Conservation (Fire) Camp Opioid Overdose Program for Inmates training will be an interactive training with Power Point. Subsequent to implementation, all training will be available through the Learning Management System (LMS).
- The parties agree, at the request of either party, this Meet and Confer table will be reopened within ninety (90) days of this agreement to address any unforeseen BU 6 impact issues that cannot be resolved locally.




