This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on August 27, 2020, regarding the implementation of the Rio Salinas Adult School Building Construction 101 Career Technical Education (CTE) Program on Facility A Yard. This Agreement becomes an Addendum to the current State Bargaining Unit 6 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2022.

1. The State (SVSP) and CCPOA agree that a chit system for all equipment will be in place before the activation of the Building Construction 101 CTE Program on FAC A, utilizing current existing materials, resources, and/or existing funds.
2. The State (SVSP) and CCPOA agree that the audible/visual building alarm for Building 521, Room 109, will be working prior to implementation of Building Construction 101 on FAC A, utilizing current existing materials, resources and/or existing funds.
3. The State (SVSP) and CCPOA agree that either party may reopen this table within ninety (90) days from activation, if newly discovered or unresolved issues could not be remedied locally.




