

**STATEWIDE AGREEMENT BETWEEN THE
CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION (CCPOA)
AND
THE STATE OF CALIFORNIA, CALIFORNIA DEPARTMENT OF CORRECTIONS AND
REHABILITATION (CDCR), DEPARTMENT OF JUVENILE JUSTICE (DJJ)
REGARDING THE STATEWIDE IMPLEMENTATION OF SENATE BILL 132 –
TRANSGENDER RESPECT, AGENCY AND DIGNITY ACT
(CDCR LOG #21-022-0, CCPOA 54572).**

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on May 26, 2012, regarding the implementation of the Senate Bill 132 – Transgender Respect, Agency and Dignity Act. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, in effect from July 3, 2020, through July 2, 2022, Article 27, Section 27.01.


- The State (DJJ) and CCPOA agree that either party may request to reopen this table within ninety (90) days from implementation of the Senate Bill 132 - Transgender Respect, Agency, and Dignity Act, to discuss unforeseen or newly identified issues that cannot be resolved locally.
- The State (DJJ) and CCPOA agree, DJJ shall provide the additional Just Detention International LGBTI Youth Specific Training for all BU6 staff in a Block Training style format.
- The State (DJJ) and CCPOA agree, DJJ shall provide training to all BU6 staff via memorandum prior to the implementation of Senate Bill 132 - Transgender Respect, Agency, and Dignity Act.






