IMPLEMENTATION OF SERVICES IN THE DEVELOPMENTAL DISABILITY PROGRAM IN
PSYCHIATRIC INPATIENT PROGRAMS POLICY AND PROCEDURE

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on May 13, 2022, regarding the statewide California Department of Corrections and Rehabilitation, Division Of Adult Institutions (DAI), Mental Health Management Unit Implementation Provision of Services in the Developmental Disability Program In Psychiatric Inpatient Programs Policy And Procedure. This agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, Article 27, Section 27.01, which expires on July 2, 2023.

1. The State and CCPOA agree that within 45 days of this agreement, and upon the request of the CCPOA Chapter President, CHCF and CMF may have up to two (2) CCPOA representatives meet with local management to review any updates related to the Adaptive Support Logs, Post Orders, and addendums to the Local Operating Procedures (LOPs). The two (2) representatives will each receive Official Business (OB) for up to a total of eight (8) hours.

Any issues that cannot be resolved locally may be elevated to the statewide table upon mutual agreement.

2. The State and CCPOA agree that either party may request to reopen this table within 90 days of this agreement to resolve unforeseen impact issues that cannot be resolved locally.
