STATEWIDE AGREEMENT BETWEEN THE CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION (CCPOA) AND THE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR), CALIFORNIA HEALTH CARE FACILITY (CHCF) REGARDING THE FACILITY E 301 B & 301 C CONVERSION FROM ENHANCED OUTPATIENT PROGRAM TO NON-DESIGNATED PROGRAMMING FACILITY (CDCR LOG #22-062-0, CALHR #3764, CCPOA NG71478)

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on June 17, 2022, regarding the conversion of Facility E 301 B and 301 C from Enhanced Outpatient Program to Non-Designated Programming Facility. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, in effect from July 3, 2020, through July 2, 2023, Article 27, Section 27.01.

1. CCPOA and the State (CHCF) agree that within 21 calendar days of this agreement, a

local meet and discuss will occur regarding the conversion of E301B and E301C from

EOP to Non-Designated Program Facility. Four (4) local CCPOA representatives will be

provided up to eight (8) hours of Official Business to conduct a local meet and discuss.

The discussion will include but is not limited to;

- POST order changes/amendments
- Operational Procedure changes/amendments
- Pill line operations
- ISUDT classroom location
- Orientation and program status for new arrivals
- 2. CCPOA and the State (CHCF) agree that either party may request to reopen this table within ninety (90) days of agreement to address any unresolved or unforeseen impact issues that cannot be resolved locally.
