



AGREEMENT BETWEEN  
CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION  
AND  
THE STATE OF CALIFORNIA,  
DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR),  
SUBSTANCE ABUSE TREATMENT FACILITY AND STATE PRISON IN CORCORAN (SATF),  
REGARDING THE REOPENER OF THE IMPLEMENTATION OF THE TRIAL OF  
AUXILIARY AIDS IN HOUSING UNITS  
(CDCR # 22-046-0/ CCPOA #71477)


This Agreement detracts from and revises the previous SATF Trial of Auxiliary Aid in Housing Units Agreement and represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on August 15, 2022. This agreement becomes an addendum to the current State Bargaining Unit 6 (BU6) Memorandum of Understanding, Article 27, Section 27.01 which expires on July 2, 2023.

- The parties agree all other bullets listed in this agreement will remain in full force and effect with the exception of bullet #4. Bullet #2 has been revised from the agreement dated June 27, 2022.
- The parties agree BU 6 Housing Unit staff shall not be required to maintain a constant visual of the Auxiliary Aids devices while the Auxiliary Aid users have the devices in their possession.
- The parties agree BU 6 Housing Unit staff shall not be responsible for training related to the Auxiliary Aid devices. In the absence of an ADA worker, BU-6 staff will be responsible for providing assistance to the Auxiliary Aid users on the basic operations of the Auxiliary Aid devices.
- ~~The parties agree the Auxiliary Aid devices shall be utilized by the designated Auxiliary Aid users only in the dayrooms of the identified Housing Units to ensure safety and security and device accountability.~~
- The parties agree to re-open this table at the request of either party within the timeframe of the trial period to address any unforeseen impact issues that cannot be addressed locally.




