

STATEWIDE AGREEMENT BETWEEN THE
CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION (CCPOA)
AND
THE STATE OF CALIFORNIA, CALIFORNIA DEPARTMENT OF CORRECTIONS AND
REHABILITATION (CDCR), CALIFORNIA CORRECTIONAL CENTER (CCC)
REGARDING THE DEACTIVATION OF FACILITY A
(CDCR LOG #21-074-0, CALHR #3495, CCPOA NG# 54641)

This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on November 18, 2021, regarding the Deactivation of Facility A. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, in effect from July 3, 2020, through July 2, 2023, Article 27, Section 27.01.

- CCPOA and the State (CCC) agree that two (2) local CCPOA representatives will be provided eight (8) hours of Official Business to meet with local management and discuss the updated alarm response plan.
- CCPOA and the State (CCC) agree that utilizing existing funds, materials and resources, CCC Management will review existing policy within thirty (30) days of agreement to determine options for movement of chemical agent related response gear to Main Receiving and Release.
- CCPOA and the State (CCC) agree that either party may request to reopen this table within ninety (90) days of agreement to address any unforeseen or newly identified impact issues that cannot be resolved locally.
