


STATEWIDE AGREEMENT  
BETWEEN  
THE CALIFORNIA CORRECTIONAL PEACE OFFICERS ASSOCIATION (CCPOA)  
AND  
THE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR),  
DIVISION OF ADULT INSTITUTIONS AND CALIFORNIA CORRECTIONAL HEALTH CARE SERVICES  
IMPLEMENTATION OF STAFF PRECAUTIONS FOR PATIENTS RECEIVING RADIOACTIVE IODINE TREATMENT  
(CDCR LOG #22-031-0/CCPOA #71518/CalHR #3811)

This agreement represents the full and complete understanding reached by and between the parties at the conclusion of Meet and Confer negotiations on April 13, 2023, regarding the implementation of staff precautions for patients receiving radioactive iodine. This agreement is an addendum to the current Bargaining Unit Six Memorandum of Understanding under Section 27.01 which expires on July 2, 2023.

- The State and CCPOA agree BU 6 staff shall not be required to handle and/or remove used portable urinals, emesis bags, or other biohazard items from transportation vehicles after transporting patients who received radioactive iodine treatment.
- The State and CCPOA agree the use of large single-patient transport vans, with at least 6 feet of separation between the BU 6 staff and the patient, shall be utilized for transporting patients who received radioactive iodine treatments, unless unforeseen circumstances arise (ex. vehicle breakdown).
- The State and CCPOA agree BU 6 staff shall not be required to clean the transportation vans after they have been utilized for transporting patients who received radioactive iodine treatments.




