This Agreement represents the full and complete understanding reached by and between the parties at the conclusion of the Meet and Confer negotiations on July 27, 2023, regarding the implementation of the Division of Adult Institutions, Statewide Notice Regarding The California Department Of Corrections And Rehabilitation Implementation Of Real-Time Captioning During Due Process Events For Hearing-Impaired Offenders. This Agreement becomes an addendum to the current State Bargaining Unit 6 Memorandum of Understanding, in effect from July 3, 2021, through July 2, 2023, Article 27, Section 27.01.

- The State agrees to notify CCPOA 30 days prior to implementing additional phases of CART program beyond due process events (i.e. religious, rehabilitative, and other services, etc.).
 Within 15 days of notification, CCPOA may request to reopen this table to discuss the workload impact associated with the implementation of CART beyond due process events.
- The parties agree that Bargaining Unit 6 rank and file shall not be responsible for scheduling CART services related to due process events.
- The parties agree that either party may request to reopen this table within one-hundred eighty (180) days of this agreement to address any unforeseen or unresolved impact issues.
