


AGREEMENT BETWEEN


This agreement represents the full and complete understanding reached by and between the parties at the conclusion of Meet and Confer negotiations on October 24, 2023 regarding the implementation of the Statewide STU transition from the Glock 22 to the Glock 17. This agreement is an addendum to the current Bargaining Unit Six Memorandum of Understanding under Section 27.01 which expires on July 2, 2025.


- The State and CCPOA agree a certified STU qualified Armorer will inspect and approve STU staff personally owned Glock 17 to be utilized on duty, utilizing existing funds, materials, and resources.
- The State and CCPOA agree a copy of the final STU procedure regarding the transition from the Glock 22 to the Glock 17 will be provided to CCPOA prior to implementation.
- The State (STU Management) and CCPOA agree to reopen this meet and confer table, at the request of either party, within thirty (30) days of implementation, to address any unforeseen or newly identified impact issues that cannot first be resolved locally.


