## **CRITERIA**

Employees in classifications with the CBIDs identified above shall be eligible to accrue the Mental Health and Wellness Stipend of \$100 for each qualifying pay period worked in a Bargaining Unit (BU) 18 classification as outlined below.

## Payment criteria:

- For qualifying pay periods worked between the period of July 1, 2022, through December 31, 2022, up to a maximum accrual of \$600 for the six qualifying pay periods. The stipend earned for the period of **July 1, 2022, through December 31, 2022**, shall be processed as a lump sum payment in January 2023.
- For qualifying pay periods worked between the period of January 1, 2023, through June 30, 2023, up to a maximum accrual of \$600 for the six qualifying pay periods. The stipend earned for the period of **January 1, 2023, through June 30, 2023**, shall be processed as a lump sum payment in August 2023.
- For qualifying pay periods worked between the period of July 1, 2023, through December 31, 2023, up to a maximum accrual of \$600 for the six qualifying pay periods. The stipend earned for the period of **July 1, 2023, through December 31, 2023**, shall be processed as a lump sum payment in January 2024.
- For qualifying pay periods worked between the period of January 1, 2024, through June 30, 2024, up to a maximum accrual of \$600 for the six qualifying pay periods. The stipend earned for the period of **January 1, 2024, through June 30, 2024**, shall be processed as a lump sum payment in August 2024.

The stipend shall not be part of the employee's base salary for the purpose of computing salary adjustments.
