Subject: Fair Labor Standards Act (FLSA)

This is to update the status of the Department of Personnel Administration's review of job classifications in response to the Department of Labor's more narrow definition of the Fair Labor Standards Act's (FLSA) administrative exemption. To date, a number of classes in Work Week Group (WWG) 4B and 4C have been reallocated to WWG 2 effective May 1, 1991. A Pay Letter to this effect will be forthcoming.

Attached is a list of classes that will be reallocated to WWG 2 effective May 31, 1991. As you can see, the majority of these classes are moving from WWG 4A. These classes are generally subordinate or related to those classes that were reallocated on May 1. We intend to review classes in WWG 4A as workload permits; however, if you wish us to make a determination on a particular classification, please contact your Classification and Compensation Division analyst.
