
Bob Negri began State employment in 1968 with the Department of Transportation, where he served as Chief of Employee Safety, Chief of Labor Relations and, until his death in December 1990, Chief of the Division of Personnel Management. During his career, Bob also served on the National Safety Council, and worked with the American Association of State Transportation Officials, providing consultation in the areas of personnel, training, labor relations, and safety.

Bob was an acknowledged leader in the human resources field and played a key role in defining labor relations in State government. He was a member of the State's first negotiating team, a chief negotiator in subsequent labor negotiations, and a respected advisor to colleagues and department directors.
