Government Code (GC) Section 21363.8 (enacted by Senate Bill 183, Chapter 56, statutes of 2002) provides that an eligible State peace officer/firefighter (PO/FF) member, who is also a member of Bargaining Unit (BU) 7 and is employed by the State, retires or dies on or after January 1, 2004, shall receive a retirement that is equal to 3% of his or her final compensation at retirement, multiplied by the number of years of State PO/FF service. This GC Section further provides that service under this section shall include State PO/FF service in managerial, supervisory, confidential, or other excluded or exempt positions that are related to BU 7 if their inclusion is approved by the Department of Personnel Administration (DPA).

Simply stated, employees must meet both of the following criteria to be eligible for the improved "3%@50" formula:

1. The employee must be in the PO/FF retirement category, and
2. The employee must be in State BU 7 or in a supervisory, managerial, confidential, or other excluded or exempt position that has been approved by DPA for inclusion.

Attached is the list of BU 7 (R07), supervisory (S07), and managerial (M07) classes that are included in the formula change. The list does not currently include any Career Executive Assignment (CEA) positions (class code 7500) or exempt positions. DPA will continue its review

of other excluded peace officer classifications related to BU 7 to determine if they should be included.

All service in the approved PO/FF class or position will count as PO/FF service under the new formula.

DPA has notified the California Public Employees Retirement System that the classifications on the attached list are approved for inclusion.
