This memorandum is to advise you of the premium rate reductions **effective October 1, 2008,** for the Long Term Disability Insurance Program for excluded employees. These reductions are as follows:

Premium Rate Changes for Long Term Disability Insurance

The Long Term Disability Insurance Program for **excluded employees** is an employee-paid benefit. The benefit will stay the same; however, the premium will reduce by 10 percent for each option plan for managers, supervisors, confidential and excluded employees.
