This memorandum is to advise you of the premium rate reductions **effective January 1, 2013**, for the Long Term Disability Insurance Program (LTD) for excluded employees.

Premium Rate Changes for Long Term Disability Insurance

The Long Term Disability Insurance Program for **excluded employees** is an employee-paid benefit for managers, supervisors, confidential and excluded employees. The benefit will stay the same; however, the premium will be reduced for each plan option. The maximum monthly base salary is not to exceed \$15,385 for the 65 percent plan option and \$18,182 for the 55 percent plan option. These reductions are as follows:
