- Correctional Officers; Group Supervisors, Fire Fighters, Correctional Institution; Correctional

 and Parole Service Associates who have attained an associate of arts, bachelors degree, a
 higher degree, or sixty (60) semester units, or the equivalent quarter units from an accredited
 community college or university, shall be eligible for the Educational Incentive Pay.
 Employees are not eligible while attending the Basic Academy.
- Correctional Counselors and Parole Agents who have attained a masters degree shall be eligible for the Educational Incentive Pay.
- Upon movement to another classification in the employee's vertical class series, the employee shall move from their combined salary rate (base salary plus Educational Incentive Pay) only if the to classification is not also eligible for an educational incentive. The salary rate shall not exceed the maximum of the new classification when computing the appointment salary rate.
- If an employee has an additional position, the primary position is used to determine eligibility for the differential.

CRITERIA CONTINUED

• Employees on a training and development or out-of-class assignment to an eligible classification are not eligible because eligibility is based on the employee's actual classification. If an eligible employee is on a training and development or out-of-class assignment to an ineligible classification, they shall continue to be eligible based on their actual classification.
